NOTE BY THE SECRETARIAT

- 1. This document provides an update of the preparations for the meeting of Employment and Labour Ministers, henceforth referred to as "the Ministerial meeting", at the OECD headquarters in Paris on 15 January 2016, preceded by a Policy Forum on the Future of Work on 14 January. The document includes: an update on participation; a draft agenda for the Ministerial meeting and the preceding Policy Forum. Additional information on organisational aspects of the Ministerial meeting and Policy Forum will be made available in a separate document [DELSA/ELSA/MIN(2016)1].
- 2. Delegates are asked to:
 - **CONFIRM** their Minister's attendance at the Ministerial meeting, the Future of Work Policy Forum and the informal dinner in the evening before the Ministerial meeting.
 - **INDICATE** their Minister's intention to intervene in the morning plenary session and the topic(s) to be covered.
 - **INDICATE** their Minister's preference for the break-out sessions.
 - AGREE to the proposed timetable for finalising preparations for the Ministerial meeting.

PREPARATIONS AND ORGANISATIONAL ASPECTS FOR THE EMPLOYMENT MINISTERIAL MEETING AND POLICY FORUM

1. Participation in the Ministerial meeting

- 3. A large number of countries have already confirmed their Minister's participation in the Ministerial meeting and Policy Forum. All Delegations who have not yet responded to the invitation are asked to inform the ELSAC Secretariat (by email to ELS.Ministerial2016@oecd.org) about their Minister's participation at the Ministerial meeting and Policy Forum at the latest by **30 November 2015**.
- 4. The ELSAC Secretariat will support Ministers who wish to hold bi-lateral meetings during the two days involving the Policy Forum on the Future of Work or during the Ministerial meeting. Each country may register five participants for the Ministerial meeting (1 at the main table, 2 behind and 2 in the listening room). Each country can also register five participants for the Policy Forum.
- 5. In terms of non-Member participation, on 8 July 2015, the Council agreed to invite the Ministers of Employment from Brazil, the People's Republic of China, Colombia, Costa Rica, India, Indonesia, Latvia, Lithuania and South Africa to participate in the Ministerial meeting [C(2015)88]. ELSAC has subsequently agreed through a written procedure also to invite Ministers from the two G20 countries that are not Partners in the Committee: Argentina and Saudi Arabia. In addition, the Committee agreed to invite Ministers from three non-Members with which the OECD is co-operating closely in the framework of the country programmes: Kazakhstan, Morocco and Peru. Drawing on the decision by the Committee, at its meeting on 17 September 2015, the OECD Council agreed to also invite Argentina, Kazakhstan, Morocco, Peru and Saudi Arabia, to participate in the Ministerial meeting [C(2015)122].

2. Draft agenda of the policy forum and Ministerial meeting

6. On Thursday 14 January 2016, the OECD will host the High Level Policy Forum on the Future of Work, involving Ministers, social partners and selected experts. The official Ministerial meeting will then start on the morning of Friday15 January 2016. The draft agenda proposed by the Bureau of the Ministerial meeting for the Policy Forum and Ministerial meeting is set out in Box 1. The agenda for the Forum in particular is still subject to change depending on the confirmation of speakers.

Policy Forum on the Future of Work

- 7. The High Level Policy Forum on the Future of Work will bring Ministers, academics, experts and representatives from business and trade unions to discuss the possible scenarios of the future of work and the opportunities and challenges for public policy. Each session will be organised to promote a lively and free-flowing debate. Four panellists will lead off each session with initial short interventions, together with an experienced moderator. A central feature of all sessions will be to allow time for the audience to engage and discuss with the speakers. After Session 1, participants will be asked to vote on the implications for institutions and policies of the scenarios that the experts in Session 1 will have presented. The voting exercise will feed into the discussions of Sessions 2 and 3.
- 8. Over 300 participants are expected to attend the event. Each country will be able to register up to **five** participants. BIAC and TUAC representatives as well as some key experts and other stakeholders will also participate. Each Minister attending the Ministerial meeting the following day is invited and encouraged to attend and, by prior arrangement, will be given the possibility to participate actively in the forum. All Delegations are asked to indicate to the ELSAC Secretariat (by email to <u>ELS.Ministerial2016@oecd.org</u>) by **30 November 2015** whether their Minister wants to intervene in one or more sessions of the forum.

Informal dinner for Ministers

9. In the evening of 14 January 2016, the French Vice-Chair of the Ministerial meeting, Ms. Myriam El Khomri, Minister of Labour, Employment, Vocational Training and Social Dialogue of France, invites Ministers to an informal dinner at the French Ministry.

Morning session of the Ministerial meeting

- 10. In the morning of 15 January 2016, the Ministerial meeting will be opened by the Secretary-General of the OECD, Angel Gurría, followed by the Chair of the Ministerial meeting, Ms. Joan Burton, Tanaiste (Deputy Prime Minister) and Minister for Social Protection of Ireland.
- 11. Ms. Joan Burton will chair the morning plenary session on **Promoting greater labour market resilience and inclusiveness**, a session to which BIAC and TUAC are invited to participate. The Bureau of the Ministerial proposes to structure the discussion in the morning session around the four questions for discussion included in the Issues Paper for this session [see <u>DELSA/ELSA(2015)3/REV1</u>]. Given the available space in the conference room, each delegation will be composed of the Minister or Head of Delegation and two other members. Other members of the delegation are invited to follow the plenary discussion in a listening room. Ministers are invited to focus their intervention to one of the four main questions for discussion. Initial interventions should be short (**three** minutes) in order to give all Ministers the opportunity to speak in this session. All Delegations are asked to inform the ELSAC Secretariat (by email to <u>ELS.Ministerial2016@oecd.org</u>) by **30 November 2015** whether their Minister wants to speak in the plenary session and which main topic they will cover in their intervention. The order of interventions will then be grouped around common issues for discussion.
- 12. At the end of the morning session the Chair will invite Ministers to approve the Ministerial Statement [see <u>DELSA/ELSA(2015)3/REV1</u>], including the Annex with the mandate for future OECD work on employment, which can then be publicly released in a press conference after lunch. Ministers will convene for a group photograph on the stairs of the Conference Centre just after the morning session.

Working lunch

13. Ms. Joan Burton, Tanaiste (Deputy Prime Minister) and Minister for Social Protection of Ireland invites Ministers to the working lunch. The lunch will provide Ministers with an opportunity to discuss the scope and content of a review of the OECD Jobs Strategy. An issues paper on the **Review of the OECD Jobs Strategy** is provided in DELSA/ELSA(2015)3/REV1. The outcome of the lunch would be for Ministers to call on the OECD to review and update the OECD Jobs Strategy.

Afternoon sessions

- 14. The afternoon of the Ministerial meeting will focus on specific policies that are needed to make labour markets more resilient and inclusive. The discussions in the afternoon will be organised in three parallel break-out sessions, which will be chaired by the Vice-Chairs of the Ministerial. Following discussions in the previous meeting of ELSAC, and in consultation with the Bureau of the Ministerial meeting, three themes are proposed: i) **Enhancing the quality of working lives and work-related well-being**; ii) **Skills for resilient and inclusive labour markets**; and iii) **Addressing inequalities in the labour market**.
- 15. Delegations are asked to inform the Secretariat (by email to ELS.Ministerial2016@oecd.org) about their Minister's first and second choice for the break-out sessions before 30 November 2015. The Secretariat will seek to accommodate preferences while aiming for a balanced mix of participants in each of the sessions. Each session will be opened with introductory remarks by the session Chairs. The floor is then opened to all participating Ministers to allow for a free-flowing debate. Following the break-out sessions, Ministers will return for a final plenary session, where session Chairs will report back from the break-out sessions.

3. Timetable and next steps for the Ministerial meeting

16. The following timetable is proposed:

 - Final discussion of the recommendations of the Council on i) Integrated mental health, skills and work policies and ii) Ageing and employment policies. This session will also allow the Committee to discuss the appropriate monitoring process.
 - o Presentation of the organisational aspects of the Ministerial meeting.
 - o Resolution of any outstanding matters relating to the Ministerial meeting.
- 13 November 2015: ELSAC Delegates are asked to send their final comments to the ELSAC Secretariat on the Ministerial Statement, the Issues papers and the recommendations of the Council on *i*) Integrated mental health, skills and work policies and *ii*) Ageing and employment policies.
- 25 November 2015: Revised versions of the recommendations of the Council on i) Integrated mental health, skills and work policies (4th revision) and ii) Ageing and employment policies (3rd revision) put on OLIS for ELSAC (and also the Education Policy Committee and the Health Committee).
- 27 November 2015: Finalisation of Ministerial Statement; ELSAC Secretariat to share the Ministerial Statement with Non-Member countries.
- **30 November 2015**: Delegations are asked to inform the ELSAC Secretariat about their Minister's participation in the Policy Forum and Ministerial meeting, topics covered in the morning plenary session of the Ministerial and preferences for the Ministerial afternoon break-out sessions (by email to ELS.Ministerial2016@oecd.org).
